

TERMS AND CONDITIONS OF SERVICES OF JAYDEE BEATS 2024

THE WORKING CONDITIONS ARE ACCEPTED FOR ANY CUSTOMER AT THE MOMENT THEY PAY, IN PART OR IN FULL, FOR ANY SERVICE PROVIDED BY THE COMPANY JAYDEEBEATS OF THE HOLDER JAIRO DAVID JAUREGUI DNI 33605272 OF THE COUNTRY ARGENTINA, BUENOS AIRES. COMPOSER/BEATMAKER AND MUSICAL ARRANGER REGISTRATION NUMBER MR5237076 GIVEN BY SONY PUBLISHING AND IDENTIFICATION NUMBER AS PRO COMPOSER 726403459 GIVEN BY SADAIC IN ARGENTINA.

THE PRODUCER'S CONDITIONS CONSIST OF THE FOLLOWING SAFETY CLAUSES FOR THE CUSTOMER AND THE PRODUCER:

FIRST: RIGHTS OF INTERPRETER. ANY UNPUBLISHED WORK CREATED BY THE COMPANY OR COMPOSER IN CHARGE ARE NOT ASSIGNED TO THE CUSTOMER UNTIL COMPLETION OF 100% OF THE PAYMENT AGREED BY THE COMPANY BASED ON MELODIES, MUSICAL ARRANGEMENTS, ETC. THE CUSTOMER MUST RECEIVE IN HIS EMAIL THE LEGAL PDF OF THE COMPOSER'S RIGHTS SESSION WITH THE WRITTEN DETAILS AND ATTACHED TO THE E-MAIL, A MUSIC SAMPLE IN MP3 128KBPS WITH THE AUDIO, DEMONSTRATING SAID RECORDING MADE AS VERIFICATION OF THE ORIGINAL WORK CREATED FOR THE CUSTOMER.

SECOND: DELIVERY TIMES. THE CUSTOMER MUST CHECK THE ESTIMATED TIME OF THE WORK FOR ITS SUBSEQUENT DELIVERY, IF THE DELIVERY IS DELAYED, THE PRODUCER/COMPANY JAYDEEBEATS WILL HAVE AN EXTENDED TIME EXTENSION OF 30 MORE DAYS TO MAKE THE DELIVERY, OTHERWISE, THEY MUST REFUND THE PAYMENT THAT HAS BEEN SENT FROM THE SERVICE. THIRD. ORDERS AND TIME. ALL SERVICES HAVE 1 MODIFICATION IN FAVOR OF THE CUSTOMER, WHETHER COMPOSITION, ARRANGEMENTS, EDITING, MIXING OR CHANGES IN THE MASTERING. AFTER THE MODIFICATION MADE, THE TIME IN HOURS DEDICATED TO THE SERVICE WILL ALREADY BE EXHAUSTED SO THE CUSTOMER, IF THEY REQUIRE MORE MODIFICATIONS, MUST PAY FOR THE EXTRA TIME IN HOURS. OTHERWISE THE PRODUCER/COMPANY WILL SEND THE MADE PRODUCT TO THE EMAIL TERMINATING THE SERVICE.

QUARTER. PAYMENTS. THE PAYMENT GATEWAY IS FOUND ON THE COMPANY'S PAGE OR ON ITS SOCIAL NETWORKS IN LINKS. THE SAME, IN THE FACE OF ANY SCAM, THE CUSTOMER MUST PROVIDE THAT THEY ARE LEGITIMATE. ON THE OFFICIAL PAGE THERE IS A BUTTON CALLED CREDENTIALS AND PAYMENTS WHERE ALL THE OWNER'S DATA IS HERE TO ENSURE THAT EACH LINK THE CUSTOMER RECEIVES IS OFFICIAL BEFORE PAYING THE COMPANY, FOR GREATER SECURITY WE RECOMMEND THAT PAYMENTS BE MADE WITH THE LINKS LOCATED INSIDE FROM THE PAGE WWW.JAYDEEBEATS.COM IN EITHER PAYPAL OR STRIPE FORMAT. ONCE THE PAYMENT HAS BEEN MADE, THE CUSTOMER WILL RECEIVE A BILLING INVOICE IN THEIR EMAIL WITH THE DETAILS OF THE PRODUCTION, PAYMENT ID, INFORMATION OF THE PAYMENT ISSUER AND PRODUCER IN CHARGE OF THE ORDER.

<u>FIFTH. AUTOMATIC RECYCLING.</u> EVERY 90 DAYS THE COMPANY RECYCLES DELIVERED PROJECTS THEREFORE THE CUSTOMER HAS A PERIOD OF 3 MONTHS TO REQUEST A NEW DELIVERY OF THEIR MADE PRODUCT IN CASE THEY HAVE LOST IT OR NEED TO MAKE ANY NEW CHANGE OR THEY REQUEST A BACK-UP OR PROJECT SESSION, ETC. AFTER THIS PERIOD THE COMPANY/PRODUCER JAYDEEBEATS WILL NO LONGER HAVE ANY CONTENT OF THE PRODUCT MADE.

SIXTH. PUBLICATIONS. THE COMPANY MAY PUBLISH A TRAILER OR SAMPLE OF THE WORK DONE ON ITS SOCIAL MEDIA AS AN EXPOSURE OF THE SERVICES IT PROVIDES TO ITS CLIENTS, IF THE ARTIST WANTS TO KEEP HIS CONTENT PRIVATE, HE MUST GIVE PRIOR NOTICE TO AVOID ANY SAMPLE PUBLICATION.
